RECALLABLE MEMBERSHIP

I recognition of the interim nature of my Membership, the Club may recall my Membership in its sole and absolute discretion at any time for any reason or no reason, upon written notice. If the Club recalls my Membership, the Club shall be required to pay to me any prepaid dues for any period following the effective date of the recall.

PAYMENT OF DUES, FEES, AND CHARGES

I hereby agree to pay to the Club the membership dues, plus any applicable sales tax for the category of membership selected as well as any fees or other charges. The current amount of dues for each membership category is described on a separate Schedules of Dues, Fees, and Charges, and is subject to change.

I hereby request that all dues, fees, and charges be billed directly to me through the club account.

Club accounts shall be deemed delinquent from the date first billed if payment is not received within 30 days after the date of the monthly statement. Past due bills will be subject to a 1.5% late payment charge per month, but not to exceed the maximum amount permitted by law. The late payment charge shall accrue 30 days from the date of the monthly statement until the account is paid in full.

ACKNOWLEDGMENT OF MEMBERSHIP RIGHTS

I acknowledge that membership in the Club is not an investment in La Cita Golf and Country Club, or the Club Facilities, and does not give a member a vested or prescriptive right or easement to use the Club Facilities. Membership in the Club does not provide a member with a equity or ownership or any other property interest in the Company, the Manager or the Club Facilities. A member only acquires a revocable license to use the Club Facilities on terms and conditions established by the Company from time to time, and this Membership Agreement. All rights and privileges of members under the Membership Plan, the Rules and Regulations and this Membership Agreement are subordinated to the lien of any mortgage encumbering the Club Facilities from time to time.

The Club reserves the right, in its sole discretion, to modify membership rights and privileges, to sell, lease or otherwise dispose of the Club Facilities in any manner whatsoever and to any person whomsoever, to add, issue, modify, or terminate any type or category or class of membership, to discontinue operator of any or all of the Club Facilities.

I hereby acknowledge that the use of the Club Facilities and any privilege or service incident to membership is undertaken with knowledge of risk of possible injury. I hereby accept any and all risk of injury to myself, my guests and my family sustained while using the Club's facilities or while involved in any event or activity incident to membership in the Club. I agree to release and hold the Company, the Manager, any manager of the Club Facilities, their affiliates, their successors and assigns and their respective directors, officers, partners, members, shareholders, employees, representatives, and agent and the members of any Club committee ("Released Parties") harmless in accordance with the provisions of the Rules and Regulations of the Club. Harmless from any and all loss, cost, claim, injury, damages or liability sustained or incurred by him or her, resulting from the use of the Club Facilities, arising out or incident to membership in the Club and/ or from any act or omission of any of the Released Parties, unless caused by the gross negligence or willful misconduct of any of the Released Parties.
